6.3 In the event of translation of this agreement and its annexes, the English version shall prevail.

Article 7 Project management and financing of the project

7.1 The Lead partner leading and coordination of the project with help from the steering group which consist of one contact person from each partner organisation.

7.2 The project is primarily financed by seed funding from the Swedish institute. The project budget does only cover partners costs for travel-expenses, study visits and accommodation. The project can not give any compensation for the time that the partners put into the steering group etc.




